1. **Dues:** Annual dues in the amount of \$525.00 should be mailed to the Financial Secretary's Office before June 1, 2011. If not mailed before this date, you may pay your dues (\$525.00) on site at the registration desk. *Late fee of twenty-five dollars is not included.*

1. A. Firm member (1 only) is \$ 150.00 late fee is \$25.00
(A firm member cannot hold office: But they can vote)

2. **Pre-Registration:** All members/non-members, guest and apprentices must pre-register with the Financial Secretary's Office. The Registration fee is \$ 200.00 and the deadline is June 1, 2011. A late fee of \$25.00 will be charged after June 1, 2011; On-site registration will be \$ 225.00.

Clear definition of Section 4A of the Constitution and By-
laws of the Alabama Funeral Directors & Morticians
Association, Inc.

Section 4

There shall be three (3) classes of members: firm members, general members, and student or apprentice members.

A - Firm Members. Any licensed funeral establishment in good standing with the state board of funeral service shall be a firm member. Under the firm membership any employee (s) of the firm can represent the establishment. Each employee that elects the firm membership classification will be required to pay state dues. This class of membership shall not have the right to hold an office or chair a committee.

Firm members will have one collective vote per firm. There is not a proxy option for this membership.

B- General Members. Any licensed funeral director, mortician, or embalmer who is in good standing with the state board of funeral service shall be a general member.

General members will have one vote. There is not a proxy option for this membership.

C- Student or Apprentice Members. Any student enrolled in a certified school or program of embalming or any apprentice funeral director or embalmer shall be a student or apprentice member.

Student or apprentice members will not have the right to vote or the right to hold an office.
